THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Requested below to provide early childhood educational services for the Office of Language, Cultural, and Early Childhood Education at a cost not to exceed

\$170,000 to \$330,000. Agencies were selected on a non-competitive basis pursuant to previous involvement

in the State Pre-Kindergarten program. A written agreement for Agency services is currently being negotiated

1) add 10 existing vendors; 2) add 8 additional vendors to provide classroom services under this program; 3) increase the total contract amount to \$330,000; 4) correct various errors for certain vendors; and 5) to correct various errors in the contract with the Office of Language, Cultural, and Early Childhood Education.
