**GENERAL CONDITIONS:**

Indebtedness – The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-FX3) as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted September 27, 1995 (95-0927-R18) as amended from time to time, shall be incorporated into and made a part of the agreement.

The Agreement shall contain the clause: "All expenditures covered by the grant shall be subject to the terms and conditions of the Agreement."
