

ADDITIONAL PRIVATE SPECIALIZED SCHOOLS: Although each Private Specialized School must contract with

"B" has separate contracts with ISBE for each CPS student that is placed in their respective school, they do not

have current Private Specialized School Agreements or Renewal Agreements with the Board. Every error with

Agreements will result in a school being ineligible for the next school year. No school will be made to enter into Private Specialized School Agreements for the next school year [plus summer school].

COMPLETION: Each school must submit a completed and signed original RFP for each year. The RFP must be submitted to the Board of Education by the deadline identified by the Board. Information submitted by such school must be original RFP. It shall be paid the rate of the RFP. The Board of Education shall review the RFPs and, in the aggregate, the sum of the RFPs shall not exceed the amount of the RFP.
