This License is for use of the McCormick Place Lakeside Center for the 4th Annual High School Fair on November 17, 2001. The Fair is a family event targeted at 8th grade students and their parents/guardians. The goal is to showcase the wide array of academic programs and opportunities available in the OPS high schools. Every OPS high school will be represented. The event was first held in 1998 and attracted approximately 10,000 attendees. Last year the High School Fair was held at McCormick Place South with approximately 22,000 attendees.
