Programming included a mixture of homework help, tutoring, reading and mathematics support, arts, recreation, and adult educational services. Youth programs included Summer Camp, Art, Music, Photography, Cheerleaders, Sports, Homework Help, Tutoring, Family Science, Dance, recreational

activities, and family activities. The Monroe CLC provided family reading, family science, and family math in addition to other educational services and security was provided.
