Make advisory recommendations to the principal regarding the use of teaching resources based on the results of the evaluation.

14) Develop and approve the Board of Directors' Rules and Policies.

15) Make public the names and addresses of members of the Board of Directors.

16) Develop and approve the School Uniform Policy.

17) Develop and approve the School Uniform Policy.

18) Make recommendations to the Board of Directors regarding the establishment of one or more satellite campuses.

Board of Directors' Manner of Operation. A majority of the full membership is required to take any affirmative action by the Board of Directors.

paragraphs B and C, the affirmative vote of a majority of the full membership of the Board of Directors shall be necessary to approve any business before the Board of Directors.

B) Six votes is necessary to select or renew the contract of a Principal and to select a Director of Professional Development.

Neither the Principal nor the Director of Professional Development may vote, nor be counted toward the establishment of a quorum on the following issues: principal selection, principal contract renewal, principal evaluation, approval of additional evaluation criteria, and development of the School Improvement Plan.
