

**APPROVE ENTERING INTO AGREEMENTS WITH VARIOUS AGENCIES
FOR EARLY CHILDHOOD EDUCATIONAL SERVICES**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into agreements with the agencies listed in Exhibit "A" to provide early childhood educational services to children from birth to age five and their families at a cost not to exceed the aggregate amount of \$94,000,000. Agencies were selected on a non-competitive basis pursuant to proposals solicited from community agencies and evaluated based on past services and the ability to meet program guidelines as mandated by the

Illinois State Board of Education. Written agreements for agency services are being completed. No further action is required.

COMPENSATION: Agencies shall be paid as follows: Each Agency shall be paid the sum identified in their individual agreement upon invoicing; the sum of payments to all agencies shall not exceed \$94,000,000 over a two-year period. Payments will be distributed two times each year. The first payment shall be made upon execution of the contract; subsequent payments shall be due each February and August after all financial documents have been reviewed and approved.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written agreements. Authorize the President and Secretary to execute the agreements. Authorize the Chief Early

Childhood Education Officers or the Deputy Chief Early Childhood Education Officers to execute all agreements.
