

## AT THE END OF THE 2007-2008 SCHOOL YEAR

## THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

That the Board of Education of the City of Chicago ("Board") approve the reconstitution of Robert Fulton Elementary School ("Fulton School"), Unit 3540, 5300 South Hermitage, Chicago, Illinois and remove and replace its staff, including the principal, at the end of the 2007-2008 school year.

## **DESCRIPTION:**

<u>Statutory Authority.</u> Pursuant to Section 5/34-8.3(d) of the Illinois School Code, 105 ILCS 5/34-8.3(d), and following the opportunity for a public hearing, the Chief Executive Officer of the Chicago Public Schools ("CEO") may recommend to the Board the reconstitution of a school on probation for at least one year for academic reasons, and the replacement and reassignment of its entire staff, including the principal.

Procedural History: Public Notice, Public Hearings, and the Hearing Officer's Report and Recommendation. On January 24, 2008, the CEO gave written notice of his proposal to turn around Fulton School by reconstituting the school in accordance with Section 5/34-8.3 (d) of the Illinois School Code to:
