

**RATIFY ENTERING INTO AGREEMENTS WITH VARIOUS PROVIDERS  
FOR HIGH QUALITY EARLY CHILDHOOD SERVICES**

**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Ratify entering into agreements with providers listed in Exhibit "A" to provide high quality early childhood

services to children ages birth to five and their families at a cost not to exceed the aggregate amount of \$55,710,000.00. These services were obtained without prior Board approval. Providers were selected on

a non-competitive basis pursuant to submitted proposals and evaluated on past services and the ability to
