**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Approve entering into agreements with providers listed in Exhibit "A" to provide high quality early

childhood services to children ages birth to five and their families at a cost not to exceed the aggregate amount of \$59,730,000.00. Providers were selected on a non-competitive basis pursuant to submitted proposals and evaluated on cost savings and the ability to meet program guidelines as mandated by the

**DELIVERABLES:** Providers will deliver appropriate educationally sound and research based preschool and/or infant toddler programs to eligible children enrolled in child care centers and/or case management

~~and/or parent educational services to children and families eligible for the Prevention Initiative or Parental~~

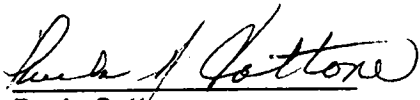
Training programs as described by the Illinois State Board of Education.

**OUTCOMES:** Providers' services will result in young children developing a strong foundation for learning and being better prepared to enter preschool and/or kindergarten. At-risk children and families will have access to coordinated services and extra preparation prior to kindergarten.

**COMPENSATION:** Each provider shall be paid quarterly upon invoicing based upon approved budgets and the number of children served during the prior quarter; the sum of payments to all providers shall not exceed \$50,720,000.00. The first payment shall be made within 30 days of contract execution.
