

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:


Approve entering into agreements with various not-for-profit organizations and agencies to provide out-of-school time programs and services to students and their families in the Chicago Public Schools Community Schools Initiative (CSI) at a cost not-to-exceed \$12,145,875 in the aggregate. Partners were selected on a non-competitive basis: the non-competitive request was presented to the Non-Competitive Procurement Review Committee, and was approved by the Chief Purchasing Officer. Written agreements for these services are currently being negotiated. No services shall be provided by and no payment shall be made to any Partner prior to execution of their written agreement.
