Providers were selected on a non-competitive basis pursuant to submitted proposals and evaluated on cost services and the ability to meet program guidelines as mandated by the

and the number of children served during the prior quarter; the sum of payments to all providers shall not exceed \$56,130,000.00. The first payment shall be made within 30 days of contract execution; subsequent payments shall be made during the months of November, March, and June after all financial and program information including budget, certification, enrollment, expenditure documents and reports


