The Renewal and any related contracts must be executed by the current contract's expiration date in order for First Quarter funding to be released for the new contract term. The charter and Charter School Agreement were subsequently renewed for a term commencing July 1, 2004 and ending June 30, 2021

more than 617 students in grades K through 8. The Charter School Agreement was subsequently renewed for a term commencing July 1, 2021 and ending on June 30, 2023, and it is authorized to renew the operation of the new Alain Locke Charter School beyond June 30, 2023, subject to the Charter School non accountability plan set forth by the Board

The Charter School submitted a renewal proposal on October 1, 2021. The charter school shall be located at 3141 West Jackson Boulevard, Chicago, Illinois 60612, through 8 with a maximum enrollment of 617

The agreement will incorporate an accountability plan in which the charter school is evaluated by the Board each year based on numerous factor
