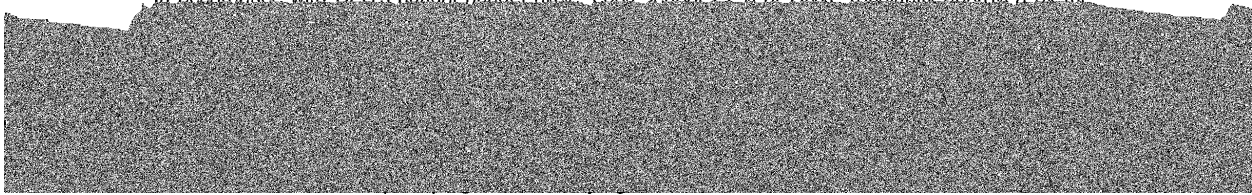

Individual CIWPs and budgets were developed collaboratively at each school with the assistance of the Network Chiefs of Schools, the Office of Innovation and Incubation, the Academy of Urban School Leadership (AUSL), the Office of Management and Budget, Local School Councils, parent and community representatives and school personnel, as applicable. Each school's CIWP includes specific priorities and strategies, and each school's budget includes specific expenditures identified for correcting

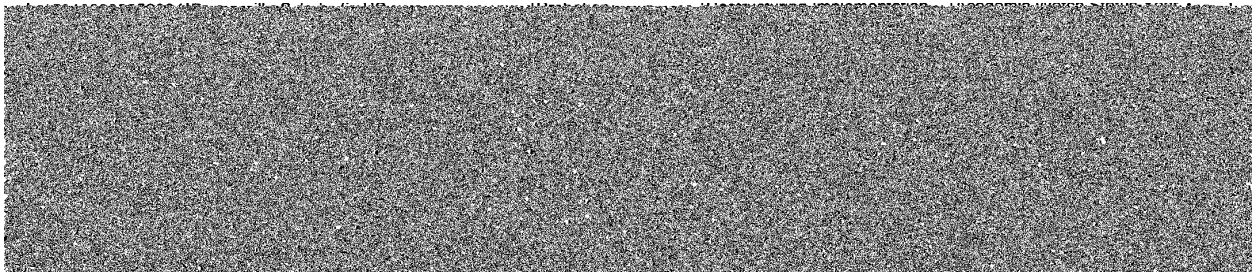


applicable, with the assistance of the Office of Accountability and the Office of Network Support. The Network Chief of Schools, Chief of Strategic School Support Services, or the Chief Executive Officer of AUSL are authorized to modify a probation school's CIWP as necessary to correct deficiencies throughout the school year.

FINANCIAL: Within budgetary appropriations.




